Ms. Gardner was the recipient of the 100 Women in Hedge Funds' 2008 Industry Leadership Award, which recognizes individuals whose professional dedication, passion, and ethics set a standard of excellence for the industry. Ms. Gardner is also actively involved in Avenue's representation as a member of the Asset Managers' Committee of the President's Working Group on Financial Markets, which has worked to develop "best practices" for the alternative asset management industry.

As a volunteer and contributor to 100 Women in Hedge Funds over the past several years, I have seen the organization evolve to become an extensive global volunteer network of thousands of professionals across the U.S., Europe, and Asia.
